# STATE OF MONTANA DEPARTMENT OF NATURAL RESOURCES AND CONSERVATION MINUTES OF THE BOARD OF OIL AND GAS CONSERVATION MEETING

#### CALL TO ORDER

The regular business meeting of the Montana Board of Oil and Gas Conservation was called to order by Chairman Linda Nelson at 2:00 p.m., Wednesday, October 24, 2007 in the conference room of the Petroleum Club on the 22<sup>nd</sup> floor of the Crowne Plaza Billings in Billings, Montana. Board members present were Chairman Linda Nelson, Vice-Chairman Wayne Smith, Don Bradshaw, Ronald S. Efta, Jack King, Bret Smelser and Joan Stahl. Staff present were Jim Halvorson, George Hudak, Terri Perrigo, Norman Clyde Peterson, Tom Richmond and Steve Sasaki.

#### APPROVAL OF MINUTES

MOTION: Mr. Smelser made a motion to approve the minutes of the September 5, 2007 business meeting. The motion was seconded by Mr. Bradshaw and unanimously passed.

## **OPPORTUNITY FOR PUBLIC COMMENT**

Dave Galt, Executive Director of the Montana Petroleum Association (MPA) talked about the essay contest. The topic this year has to do with the price of gas, influences and economic drivers on the price of gas and how alternative fuels affect the price of gas. The deadline for essay submission is January 18, 2008. More information about the essay contest is available on the MPA website.

### BOND REPORT

Mr. Halvorson presented the Bond Report attached as Exhibit 1.

#### FINANCIAL REPORT

Ms. Perrigo handed out the financial report attached as Exhibit 2. She also distributed the proposed schedule for 2008. There were some suggested changes to accommodate attendance at NAPE in February and for other scheduling conflicts. Ms. Perrigo will incorporate the changes into the final schedule and post it on the website.

#### DEFAULT DOCKET

Mr. Halvorson presented the docket status sheet attached as Exhibit 3.

### STAFF REPORTS

Mr. Sasaki reported the cleanup of the Peterson 28-1 well site by TOI/Par Investments is almost complete. He distributed before and after pictures of the location. Mr. Mike Gleason of Par Investments said they re-entered the wellbore, will produce the well, and anticipate getting 15-20 barrels of oil per day. They are having trouble selling oil though because of pipeline issues.

Mr. Robert Zimmerman of Zimco was present to give a report regarding the Heringer 11-21 well as required by Board Order 226-2007. Everything is in compliance and he has all the delinquent production reports with him. He is also having difficulty finding a buyer for his oil. He produced the well for about 30 days and it made 12 bbls a day. He thanked the Board for the opportunity to fix the problem and said field staff has been very helpful.

Mr. Hudak said, in response to a question raised at a previous meeting, that Wyoming uses the same injection pressure calculations as Montana.

Mr. Hudak brought up an issue regarding Hawley Oil Company (Hawley). They were delinquent on reporting for three Madison Formation injection wells. When they finally sent in the reports they were filled out incorrectly. Billings office staff correctly filled out replacement reports and sent them to Hawley for signature. Nothing has been returned. Mr. Hudak sent Hawley a letter regarding the matter, which is attached as Exhibit 4. He recommends the Board fine Hawley \$100 and order them to submit the reports by the next hearing and keep future reports current.

<u>MOTION</u>. Mr. King made a motion, seconded by Ms. Stahl and unanimously passed, to fine Hawley Oil Company \$100 for failure to submit required reports, to give them until the Board's December hearing to submit them or a show-cause hearing will be scheduled for January 2008, and that Hawley be put on notice that all future reports must be filed timely.

Mr. Hudak reported on an enforcement issue with Carrell Oil Co. (Carrell) The Government #4 well failed its MIT last September. Carrell continued to inject and also exceeded authorized injection pressure. Mr. Hudak sent Carrell a letter about this matter which is attached as Exhibit 5. Unauthorized injection is categorized as a high level violation of Board rules and constitutes a significant non-compliance under the UIC program's Civil Penalty Policy. Although the well is now back in compliance, Mr. Hudak recommends a \$2,500 minimum fine be assessed for the significant non-compliance and that Carrell be directed to submit corrected monthly reports and a workover report for this well.

<u>MOTION</u>: Mr. Smith made a motion to fine Carrell Oil Co. \$3,000 instead of the recommended amount for the significant non-compliance and for incorrect reporting. Mr. Smelser seconded the motion and it passed unanimously.

Mr. Halvorson brought up another issue with Carrell. They have not turned in any reports since the last time they were on the delinquent reporters list, were fined, and were threatened with further Board action. He sent Carrell a letter on June 18 saying receipt of their reports would be closely monitored because of their history of continued failure to file them (both production and injection). Mr. Halvorson recommends Carrell be fined \$100 for failure to file timely reports and that that correct and current reports be filed by the Board's December 5<sup>th</sup> business meeting or schedule a show cause hearing for January 2008.

<u>MOTION</u>: Mr. Efta made a motion to double the recommended fine amount to \$200, to require that current and correct reports be filed by Dec 5<sup>th</sup> or a show cause hearing will be scheduled for the first hearing in 2008, and to notify Carrell that their fine amount will be doubled again if their reports are more than 30 days delinquent in the future. Mr. Smith seconded the motion and it passed unanimously.

Mr. Richmond said Spectrum Group Architects (Spectrum) of Billings was selected for the building remodel and Kathleen Armstrong of Spectrum will be the project architect.

Mr. Richmond said the Board will probably get a request from DNRC's Technical Advisory Committee (TAC) to modify Board Order 99-99. The Board issued order 99-99 when the Department of Natural Resources and Conservation (DNRC) adopted the Controlled Groundwater Area and the Technical Advisory Committee (TAC) regarding coal bed methane development in southeastern Montana. Board Order 99-99 requires that TAC be provided monitoring plans. Now they've got a lot of data and want to make recommendations to the Board about how to modify the requirements.

The summer teacher workshop will be June 23-27, 2008.

Mr. Richmond sent a letter to contractors to stop working on the Exchange Network Node project until a signed grant extension is received from EPA.





The North American Prospect Expo (NAPE) will be held in Houston February 7 & 8, 2008. Mr. Richmond will make arrangements to attend. Mr. King wants to go also, and if anyone else is interested in attending please let Mr. Richmond know.

Mr. Bradshaw said the next IOGCC meeting is May 3-5, 2008 in Calgary Alberta Canada. He also read the following statement for the record regarding the death of John O. Brown. "Eight days after our last Board meeting in September of 2007, the State of Montana learned John O. Brown Sr. perished in a plane accident in Washington. I think it proper to recognize his passing by incorporating in our minutes our regrets to his family, friends and business associates. John and his company have been an important part of the oil and gas industry in the State of Montana for many years."

# EXEMPT STAFF PERFORMANCE EVALUATIONS

Ms Perrigo distributed a historical report on exempt staff salaries which is attached as Exhibit 6. <u>MOTION</u>: Mr. Smelser made a motion, seconded by Mr. Smith and unanimously passed, to increase all exempt staff salaries by 5 percent effective October 1, 2007.
