Cardinal Oil, LLC ("Applicant"), 2650 Overland Avenue, Billings, Montana 59102, presents the following Application:

- 1. Applicant is an interest owner and operator within all of Section 27, Township 10 North, Range 31 East, Rosebud County, which lands are presently subject only to Board Rule Nos. 36.22.702 and 703 as to the Heath Formation.
- 2. Applicant proposes to drill a horizontal Heath Formation well within and upon Section 27, at any location not closer than 200' to the north/south boundaries (heel and toe setback) and 500' to the east/west boundaries (lateral setback).
- 3. Total vertical depth of Applicant's proposed test well is above six thousand feet (6,000') subsurface.
- 4. Applicant believes that Board approval of the request herein will provide the flexibility necessary to economically and efficiently drill Applicant's proposed Heath Formation horizontal test well.
- 5. In the event Applicant's single lateral Heath Formation well referred to above is authorized by this Board and thereafter drilled and completed as a well capable of commercial production of Heath Formation oil and associated natural gas, within ninety (90) days of such completion Applicant will file an appropriate application with the

Board requesting a permanent spacing unit for said well and Heath Formation oil and associated natural gas produced therefrom.

- 6. Applicant believes the granting of the request herein will serve to protect the correlative rights of all interested parties and will be in the best interests of prevention of waste and conservation of Heath Formation oil and natural gas produced in association therewith.
- 7. Applicant advises that certain evidence and testimony in support of the Application will be provided in Affidavit form.

WHEREFORE, Applicant requests the following:

- 1. This matter be set for hearing by this Board and notice thereof be given as required by law;
- 2. After hearing this matter the Board enter its Order designating all of Section 27 the subject hereof as a temporary spacing unit and authorizing Applicant to drill, complete and produce Heath Formation oil and associated natural gas therefrom; and
- 3. For such other or additional relief as this Board may deem appropriate.
