IN RE THE APPLICATION OF DENBURY ONSHORE LLC FOR AN ORDER CREATING A PERMANENT SPACING UNIT COMPRISED OF LOTS 3 & 4 (a/k/a W/2SE/4), SW/4 OF SECTION 8, AND LOTS 1 & 2 (a/k/a W/2NE/4), NE/4NW/4, NE/4NW/4NW/4, NE/4SE/4NW/4 OF SECTION 17, TOWNSHIP 4 NORTH, RANGE 62 EAST, M.P.M., FALLON COUNTY, MONTANA (TO BE COMBINED WITH ADDITIONAL LANDS LOCATED IN THE STATE OF NORTH DAKOTA) FOR THE PRODUCTION OF OIL AND ASSOCIATED NATURAL GAS FROM THE MISSION CANYON FORMATION/MADISON GROUP THEREUNDER, AND SUCH OTHER AND FURTHER RELIEF AS THE MBOGC MAY DEEM APPROPRIATE.

[A] Presents the following application:

1. Applicant is an interest owner and operator within the above-described tract, and its Little Beaver East MC22-17NH well has been successfully completed as a commercial producer of oil and associated natural gas from the Mission Canyon formation/Madison Group thereunder.

2. The Little Beaver East MC22-17NH well is completed in a reservoir containing accumulations of oil and associated natural gas in the Mission Canyon formation/Madison Group. To efficiently and economically develop the reservoir, and to protect the correlative rights of all owners, Lots 3 & 4, SW/4 of Section 8, and Lots 1 & 2, NE/4NW/4, NE/4NW/4NW/4, NE/4SE/4NW/4 of Section 17, Township 4 North, Range 62 East, M.P.M., Fallon County, Montana (to be combined with additional lands located in the State of North Dakota), should be designated a permanent spacing unit for the production of oil and associated natural gas from the Mission Canyon formation/Madison Group.

[B] Requests:


1. This matter be set for hearing, with notice given as required by law and the MOU; and
