- 2. It is anticipated that the captioned lands will comprise a PSU for purposes of Bakken/Three Forks formation production, as to Applicant's Flik 12-13 XE 1H well, pursuant to Montana Board of Oil and Gas Conservation Order No. -2024.
- 3. As of the date of this application, Applicant has been unable to establish voluntary pooling of all interests within the PSU with respect to the Flik 12-13 XE 1H well, and it is anticipated that such pooling cannot be consummated prior to the hearing on this application.
- 4. In the absence of voluntarily pooling all interests within the proposed PSU, the pooling of all interests in the spacing unit for the development and operation thereof should be effectuated by an order of the Board for that purpose.

[B] Requests:

- 1. This matter be set for hearing, with notice given as required by law and the MOU;
- 2. After hearing the matter, the Board enter its order pooling all interests in the PSU comprised of All of Sections 12 and 13, Township 25 North, Range 53 East, and Sections 7 and 18, Township 25 North, Range 54 East, M.P.M., Richland County, Montana, for the production of oil and associated natural gas from the Bakken/Three Forks formation with respect to the Flik 12-13 XE 1H well, and authorizing recovery of non-consent penalties in accordance with Section 82-11-202(2), M.C.A., with respect to the Flik 12-13 XE 1H well.
